

ROBERTS R5601 Vinyl Seam Adhesive



DESCRIPTION:

ROBERTS R5601 Vinyl Seam Adhesive is a specifically formulated flammable solution for chemically seaming vinyl sheet flooring. It is not recommended for vinyl sheet flooring with a urethane wear surface.

SURFACE PREPARATION:

Seams must be dry and free of adhesive. Wipe the seam area with a clean cloth dampened with water. Allow the area to dry before applying ROBERTS R5601 Vinyl Seam Adhesive.

APPLICATION:

Seams must be dry and free of adhesive. Wipe the seam area with a clean cloth dampened with water. Allow the area to dry before applying ROBERTS R5601 Vinyl Seam Adhesive.

CLEAN UP:

To clean up equipment and adhesive spills, Use ROBERTS R900 Clearer.

ROBERTS R900 is not recommended for removing adhesive from vinyl, carpet, or painted surfaces.
