Inhalation: Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest untilfully recovered. If breathing laboured and patient cyanotic (blue), ensure airways are clear and have a qualifiedperson give oxygen through a facemask. If breathing has stopped apply artificial respiration at once. In the eventof cardiac arrest, apply external cardiac massage. Seek immediate medical advice.

Skin Contact: This material, or a component of the material, can be absorbed through the skin with resultanttoxic effects. If skin or hair contact occurs, immediately remove contaminated clothing and flush skin and hairwith running water. 5. FIRE FIGHTING MEASURES

Suitable extinguishing media: If material is involved in a fire use alcohol resistant foam, standard foam or dry agent (carbon dioxide, dry chemical powder).

Specific hazards: Flammable liquid and vapour. May form flammable vapour mixtures with air. Flameproof equipment necessary in area where this chemical is being used. Nearby equipment must be earthed. 6. ACCIDENTAL RELEASE MEASURES

SMALL SPILLS
