## A1 Type and intended use of product

The WPA Aqualay External Above Ground Waterproofing Membrane is suitable for application onto concrete & masonry block work, Screeds and renders, Wet area grade plasterboard, CFC and fibre cement sheeting, PAA structural and marine plywood &, Autoclaved aerated concrete panels (AAC).

## A2 Description of product

WPA Aqualay is a 0.57mm thick sheet membrane consisting of an EVAC core with a laminated non-woven geotextile fleece on either side of the central core.

## A3 Product specification

The WPA Aqualay External Above Ground Waterproofing Membrane meets the requirements of a Class II, medium extensibility membrane, when tested in accordance with the requirements of AS/NZS 4858:2004(R2020), and when the product thickness is ~0.57mm on concrete, plywood, fibre cement, particleboard, and plasterboard substrates.
